In this Report, seasoned China expert and former diplomat Charles Parton analyses how Chinese reform (or a lack thereof) since the Third Plenum of 2013 has seen the country plateau. Parton investigates the likely priorities for Xi Jinping and the Chinese Communist Party (CCP) at the next Third Plenum, as well as its awkward timing.

Given the enormous scope of Xi Jinping's 2013 ambitions, the focus of this Report is on CCP reforms to the issues most fundamental to making the party-state model sustainable in the long-term.


